I have 5 girls in my office working vaccination clinics every week and I know other county departments are doing the same. So for now – I am going to just try my best to run the 2021 County Campaign from my Living Room!</i></p> <p><i>I wanted to ask for your support as I reach out to all Department Heads to run a campaign in their office. I also wanted to throw an idea at you that might help each county department “sell” the campaign and see if you would allow me to offer it to department heads as an incentive to give to the campaign through payroll deduction. I know most departments allow staff to wear jeans on Fridays as long as they are not out at public meetings or something that they need to look professional at – I wondered if the Board of Supervisors would allow us to give an incentive to all county employees that give at least \$26 (50 cents a week) through payroll deduction to receive a sticker sheet with 5 other days of the year they can choose to wear jeans in support of United Way.
