Chairman of the Wyoming County Board of Supervisors, Jerry L. Davis reports as of earlier today, Tuesday, June 09, the Wyoming County Health Department report eighty-four (84) lab-confirmed positive cases of COVID-19 among Wyoming County residents. That is an increase of one (1) case since the last reported increase on Monday, June 08.
