Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, As of earlier today, Thursday, July 30, the Wyoming County Health Department reports one hundred six (106) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is unchanged from the last reported increase on Tuesday, July 28.
