Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reports, as of earlier today, Monday, August 3rd, the Wyoming County Health Department reports one hundred nine (109) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of two (2) from the last reported increase on Friday, July 31.
