Chairman of the Wyoming County Board of Supervisors, **Jerry L. Davis**, reports, as of earlier today, Tuesday, August 4th, the Wyoming County Health Department reports one hundred ten (110) lab-confirmed positive cases of COVID-19 among Wyoming County residents. There is no increase from the last reported increase on Tuesday, August 4th.
