Wyoming County Board of Supervisors Vice Chair, **Rebecca J. Ryan**, reports, as of earlier today, Monday, September 14<sup>th</sup>, the Wyoming County Health Department reports one hundred twenty-three (123) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of two (2) cases from the last reported increase on Friday, September 11, 2020.
