Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Monday, September 28th, the Wyoming County Health Department reports one hundred thirty-two (132) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of two (2) from the last reported increase on Thursday, September 24, 2020.
