Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Thursday, October 15th, the Wyoming County Health Department reports one hundred sixty-three (163) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of three (3) from the last reported increase on Wednesday, October 14, 2020.
