Wyoming County Board of Supervisors Chairwoman, **Rebecca J. Ryan**, reports, as of earlier today, Friday, October 23rd, the Wyoming County Health Department reports one hundred eighty-six (186) lab-confirmed positive cases of COVID-19 among Wyoming County residents. This is an increase of three (3) cases from the last reported increase on Thursday, October 22, 2020.
