**From the Wyoming County Department of Health:**

If you are in the Phase 1A or 1B Priority Population according to the NYS Department of Health [“Phased Distribution of the Vaccine”](#) guidelines, you are currently eligible to receive a COVID-19 vaccination.

The Health Department received a small allocation of vaccine this week, which NYS requires be used only for essential workers in Phase 1B of the Priority Population. Additional COVID-19 vaccination clinics will be scheduled when more vaccine is received. The Health Department cannot take reservations over the phone. Please check back frequently at [www.wyomingco.net](http://www.wyomingco.net) for updated information.

Those who are age 65 or older can be vaccinated at pharmacies or the New York State mass vaccination sites, depending on the supply of vaccine. [HERE](#) is a current list of locations in Wyoming County that are registered with New York State as vaccine clinics. Appointments are subject to vaccine availability.

At current vaccine supply levels from NYS, it may take months to vaccinate everyone eligible in Phases 1A and 1B.

**Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan** announced as of Wednesday, January 27, 2021, the Wyoming County Health Department reports one thousand eight hundred fifteen (1,815) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of thirteen (13) cases from the last reported increase on Tuesday, January 26, 2021.
