From the Wyoming County Department of Health:

If you are in the Phase 1A or 1B Priority Population according to the NYS Department of Health [“Phased Distribution of the Vaccine”](#) guidelines, you are currently eligible to receive a COVID-19 vaccination.

The Health Department received a small allocation of vaccine this week. NYS mandated this vaccine be used for essential workers in Phase 1B of the Priority Population including education workers, public safety (fire, police, corrections, EMS), registered childcare providers and public facing grocery store workers. Future COVID-19 vaccination clinics will be scheduled when more vaccine is received. Check back frequently at www.wyomingco.net for updated information.

Those who are age 65 or older can be vaccinated at pharmacies or the New York State mass vaccination sites, depending on the supply of vaccine. [HERE](#) is a current list of locations in Wyoming County that are registered with New York State as vaccine clinics; appointments are subject to local vaccine availability.

If you received your 1st dose of Moderna vaccine on January 12, 13 or 14 at the Wyoming County Highway Department, watch for an email from the Health Department scheduling the time and date of your 2nd dose of vaccine.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Thursday, January 28, 2021, the Wyoming County Health Department reports one thousand eight hundred forty-four (1,844) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of twenty-nine (29) cases from the last reported increase on Wednesday, January 27, 2021.
