From the Wyoming County Department of Health:

The Health Department received one hundred 1st doses of Moderna COVID-19 vaccine from NYS this week. Second dose clinics are in process. At this time, New York State [Executive Order 202.91](#) requires health departments to focus on essential workers in Priority Population 1B.

If you are in the Phase 1A or 1B Priority Population according to the NYS Department of Health [“Phased Distribution of the Vaccine”](#) guidelines, you are currently eligible to receive a COVID-19 vaccination.

Beginning the week of February 15, 2021 adults of any age with certain pre-existing conditions will be eligible to be vaccinated. The Health Department will schedule clinics for next week based on vaccine supply and updated guidance from NYS. Continue to check www.wyomingco.net for clinic availability.

Next week appointments will be available on Tuesday, 2/16/21 and Thursday, 2/18/21 between 10:00am and 12:00pm both days.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Thursday, February 11, 2021, the Wyoming County Health Department reports one thousand nine eighty-two (1,982) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of twelve (12) cases from the last reported increase on Wednesday, February 10, 2021.
