From the Wyoming County Department of Health:

If you are in the Phase 1A or 1B Priority Population according to the NYS Department of Health [“Phased Distribution of the Vaccine”](#) guidelines, you are currently eligible to receive a COVID-19 vaccination.

Beginning the week of February 15, 2021 adults of any age with certain pre-existing conditions will be eligible to be vaccinated. The Health Department will schedule clinics for next week based on vaccine supply and updated guidance from NYS. Continue to check www.wyomingco.net for clinic availability.

NEW: Free COVID-19 rapid testing will be available by appointment at the Health Department each week. Next week appointments will be available on Tuesday, 2/16/21 and Thursday, 2/18/21 between 10:00am and 12:00pm both days.

Wyoming County Board of Supervisors Chairwoman, Rebecca J. Ryan announced as of Friday, February 12, 2021, the Wyoming County Health Department reports one thousand nine hundred ninety-three (1,993) lab-confirmed positive community cases of COVID-19 among Wyoming County residents. This is an increase of eleven (11) cases from the last reported increase on Thursday, February 11, 2021. Health Department staff will be working over the holiday weekend, reporting will resume on Tuesday, February 16, 2021.
