Action Steps

- Develop a listing of places that provide the training.
- Identify where to disseminate the info & how to promote.

2. Develop a list of tri-county sharps disposal & medicine disposal.

Continuum of care for chemical dependence services

Chemical dependence withdrawal and stabilization services – Detox - part 816

1. Medically managed – acute, severe withdrawal
2. Medically monitored – mild to moderate withdrawal
3. Ambulatory withdrawal services – outpatient – mild to moderate

Inpatient Rehabilitation Services – part 818

1. Generally 30 days or less
2. Treatment/counseling is provided within the program
3. Referrals are made to residential and outpatient upon completion
4. Mixed, men's, women's and adolescents

Chemical Dependence residential rehabilitation Services for Youth – part 817

1. Under 21 years of age
2. Long term residential settings with treatment/counseling provided within the service.
3. Minimum of 40 hours of services per week of services

Chemical dependence residential services – part 819

1. Community residence – 3 to 6 months
 - a. Recovery skills
 - b. Vocational/educational skills
 - c. Daily living skills
 - d. Treatment provided in outpatient setting
2. Supportive living apartments – 6 months to 2 years
 - a. Voc/ed skills
 - b. Recovery skills
 - c. Relapse prevention
 - d. Reintegration back into the community

Chemical dependence residential services – part 820 (known as residential redesign)

1. Stabilization – mild to moderate withdrawal – 2 weeks
2. Rehabilitation – treatment/counseling is all provided within the unit – 3 to 6 months
3. Reintegration – what is known as supportive living or community residence – 6 months to 2 years
 - a. Treatment is provided in outpatient setting

Chemical dependence outpatient services – part 822

1. Intensive – removed from regulations, but programs still offer. Minimum of 9 hours per week
2. Standard
3. Outpatient rehabilitation – 3 to 5 days per week with a minimum of 4 hours per day
4. Opioid treatment services – methadone
